Overview - the basic information you need to know

- A. Who we are: We are the Hermes Healthcare Limited, the owner and provider of the AI-Care platform and the myAthlos platform, digital health applications that facilitate the collection and integration of patient/citizen (AI-Care) and student/athlete (myAthlos) data from medical databases and patient/citizen/student/athlete devices, which may be accessed by healthcare/education/sports professionals and collaborating organizations. Our company number is 10775217 and our headquarters are at 71-75 Shelton Street, Covent Garden, London, WC 2H9JQ, England. Hermes Healthcare Greece I.K.E is a subsidiary company of Hermes Healthcare Limited, with Tax Registration Number: 801491890 based in Thessaloniki, Greece at Komninon 17 street, TK, 54624. Hermes Healthcare Limited & Hermes Healthcare Greece I.K.E are the controllers of your personal information and are responsible for your personal information/data. All references in this policy to "Company", "our", "us" or "we" refer to Hermes Healthcare Limited, or its subsidiaries and our group companies, as the case may be. All references in this policy to "our website" refer to our website at https://hermes.health
- **B. Our values and what this policy is:** We value your privacy and want to be accountable and fair to you, as well as transparent about how we collect and use your personal information.

1. How we obtain your personal information

1.1 You may provide us with your personal information voluntarily. We may also receive information about you from third parties, such as marketing companies, market research companies, suppliers, our contractors and



consultants, group companies, public websites and public services, which are referred to as "third party sources" or "suppliers" throughout this policy.

1.2 You may provide us with personal information about yourself by using the online forms provided on our websites, the AI-Care & myAthlos platforms and our applications that connect to and operate within the platforms, by creating an account with us, by using bulletin boards or forums on our website or by contacting us by phone, email or other means. This includes, for example, where you provide us with your personal information to receive products, deliveries, information or services from us. If you are a supplier, you may also provide us with personal information about yourself when you offer or provide services to us.

2. Collection of your personal information and how we use it

- a . <u>How we use your personal information</u> We will collect, use and We store the personal information listed above for the following reasons:
 - i . to provide you with the Al- Care & myAthlos applications and platforms by Hermes Healthcare
 - ii . to help you manage your profile, preferences and other options on Hermes Healthcare's AI - Care & myAthlos applications and platforms and the related services.
 - iii . to communicate with your doctor or the health /education/sports professionals who collaborate or not necessarily with them, to access and upload your medical records and other documents and information regarding your medical history and your daily experience, to the Al-Care & myAthlos applications and platforms by Hermes Healthcare
 - iv . to track your activity levels
 - v . record and collect your symptoms, mood, change in any physical or mental or spiritual characteristic, as well as your compliance with the treatment and/or health prevention plan you are following
 - vi . allow named doctors, pharmacists and/or health/education/sports professionals to access your medical records and other recorded information through Hermes Healthcare's Al-Care & myAthlos applications and/or platforms in order to provide you with care or treatment or any other recommended course of action
 - vii . to propose suitable projects or initiatives managed or developed by the Hermes Healthcare or third parties
 - viii. for the purpose of anonymizing certain categories of such personal information, by aggregating such anonymous data with the anonymous data of other users of the Hermes Healthcare's AI Care & myAthlos platforms and the provision of this data to third parties, in order for these third parties to collect, use and store this anonymized data for research into medical conditions, trends and treatment development, compliance and effectiveness of treatments.

b. <u>Source of personal information.</u> We receive your personal information from you and from your doctor, pharmacist and other health/education/sports professionals, the organization IDIKA (Electronic Governance of Social Security S.A.) or the healthcare organization that collects and stores your medical records and related information or from other collaborating organizations, associations, institutes.



c. <u>Location data.</u> Certain Services will use location data sent from any mobile phone or other controlled mobile devices, whether owned or not by you ("Device"). You can disable this feature at any time by turning off location services settings for Hermes. Healthcare apps on the device. If you use these location services, you consent to us, the Hermes subsidiaries Healthcare and the licenses of Hermes Healthcare's' Al-Care & myAthlos applications and platforms, to transmit, collect, maintain, process and use location data and queries, to provide and improve location-based products and services. You can withdraw this consent at any time by disabling location services settings on the relevant device.

2.4 Prospective customers to whom we send marketing communications

b. How we use your personal information

We will collect, use and store the personal information listed above if you have consented or, otherwise, if it is in our legitimate interest to assess your suitability for any vacancies, to contact you (including by telephone, email or post) with information about our company, our products and services, the recruitment process and the progress of your application that you either request or that we believe will be of interest to you.

- c. <u>Source of personal information</u>. We may receive some of your personal information from third parties, such as recruitment agencies or through referrals.
- d. <u>Special categories of data.</u> Some of the personal information we collect about you or which you provide to us about you may be special categories of data. The special categories data includes information about physical and mental health, information about the background check, including criminal history and union membership

2.6 People who contact us with questions

b. How we use your personal information

2.7 Our suppliers and our suppliers' employees

- b. <u>How we use your personal information</u> we will collect, use and store the personal information listed above for the following reasons:
 - i . so that we can purchase and receive products and services from you (including supplier due diligence, payments and expenses and financial controls);
 - ii . to deal with questions from you.
 - iii . confirm information regarding CVs and performance reviews to assess you or your employer's suitability to work for us.
 - iv . for monitoring equal opportunities;
 - v . for health and safety records and management and
 - vi . for security and criminal record checks (where required and which permitted by the Law).

- c. <u>Source of personal information.</u> We may receive some of your personal information from third-party sources, such as your employer or your employer's company website. We may also collect this personal information from publicly available sources, such as LinkedIn.

2.8 General uses for your personal information

Regardless of our relationship with you, we may also collect, use and store your personal information for the following additional reasons:



- a. to address any questions or concerns you have about how we collect, store and use your personal information or any requests you have made for a copy of the information we hold about you. If we do not have a contract with you, we may process your personal information for these purposes where it is in our legitimate interest for customer service purposes.
- b. for internal corporate reporting, business administration, ensuring adequate insurance coverage for our business, ensuring the security of corporate facilities, research and development, as well as for identifying and implementing business efficiencies. We may process your personal information for these purposes where it is in our legitimate interest to do so.
- c. to comply with any procedures, laws and regulations that apply to us this may include where we reasonably believe it is in our legitimate interests or the legitimate interests of others to comply, as well as where we are required by law to do so; and
- d. to establish, exercise or defend our legal rights this may include where we reasonably believe it is in our legitimate interests or the legitimate interests of others, as well as where we are required by law to do so.

2.9 Further processing

Before we use your personal information for purposes other than those listed in **section 2**, we will conduct an analysis to determine whether our new use of your personal information is compatible with the purposes set out in **section 2**. Please contact us using the contact details at **section 13**, if you would like more information about the analysis we will undertake.

3. Legal basis for using your personal information

- 3.1 The legal bases for using your personal information as set out in this policy privacy are as follows:
 - a. our use of your personal information is necessary to fulfill our obligations under any contract with you (for example, to comply with the terms of use of our applications, platforms or website that you accept by registering on the AI Care & myAthlos applications and platforms or browsing our website. or
 - b. our use of your personal information is necessary to comply with our legal obligations (for example, for health and safety reasons). or
 - c. where neither (a) nor (b) applies, the use of your personal information is necessary for our legitimate interests or the legitimate interests of others (for example, to ensure the security of our website). Our legitimate interests are:
 - i . to manage, develop and grow our business (as well as businesses of our group companies).



- ii . to operate and improve our website and applications and AI Care platform & myAthlos by Hermes Healthcare
- iii . to select suitably qualified and competent suppliers
- iv . to ensure a safe environment for employees, users and our suppliers .
- v . to carry out marketing, market research and business development
- vi . to define, monitor and ensure the execution of orders with the our suppliers. and
- vii . for administrative purposes within the company

Where we rely on our (or another person's or organization's) legitimate interests to use your personal information, we will carry out a balancing test to ensure that our (or the other person's) legitimate interests are not overridden by your interests or fundamental rights and freedoms which require protection of personal information. You can ask us for information about this balancing test using the contact details on **section 13**.

- 3.2 We may use your special categories of data (such as health and wellbeing information) where you have given your consent (which you can withdraw at any time after providing, as described below). This includes all data that you or your doctor, pharmacist, or other health/education/sports professional, the HDIKA organization or the healthcare/education/sports organization that maintains your personal records provide to us, for use within the Hermes Healthcare's AI Care & myAthlos applications and platforms..
- 3.3 We may process your personal information in certain circumstances for marketing purposes based on your consent (which you may withdraw at any time after providing, as described below).
- 3.4 If we rely on your consent to use your personal information in a particular way, but you later change your mind, you can withdraw your consent by contacting us at **privacy@hermes.health** and we will stop doing it. However, if you withdraw your consent, this may affect our ability to provide the Hermes Healthcare's AI -Care & myAthlos applications and platforms and related services to you (for example, if those services require the use of your special categories of data, such as health information).

4. How and why, we share your personal information with others

- 4.1 We may share your personal information with our group companies where it is in our legitimate interest to do so for internal administrative purposes (for example, for corporate strategy, compliance, auditing and monitoring, research and development, machine learning and quality assurance).
- 4.2 We will share your personal information with the following third parties or categories of third parties and data controllers:
 - a. Microsoft Azure Cloud Services, which hosts and provides you with Hermes Healthcare applications and platforms on our behalf
 - b. we may share anonymous and aggregated statistics with our suppliers to show what interest there has been in any marketing campaign that we have helped our suppliers run
 - c. we may also share anonymous data collected through Hermes Healthcare's' Al-Care & myAthlos applications and platforms in combination with the anonymous data of other users of Hermes



Healthcare's 'AI - Care & myAthlos applications and/or platforms with third parties, such as Life Science companies, health data analytics and/or health research companies, health, education, sports organizations, government agencies, and insurance companies, so that third parties can collect, use, and store this data for research into medical conditions, trends, and the development of treatments - drugs, compliance, and effectiveness of treatments

- d. our other service providers and subcontractors, including payment processors, utility providers, technical and support service providers, insurers, logistics providers and cloud service providers;
- e. public services and emergency services
- f . companies that assist with marketing, advertising and promotional activities, such as marketing automation platforms.
- g. analysts and search engine providers who help us improve and optimize our website.
- 4.3 We will always ensure that any third parties to whom we share your personal information are subject to confidentiality and security obligations, in accordance with this privacy policy and applicable laws.
- 4.4 We will also disclose your personal information to third parties:
 - a. where it is in our legitimate interest to do so, to grow and develop our business:
 - b. if we sell or buy any business or asset, we may disclose your personal information to the prospective seller or buyer such or business or assets.
- c. . if substantially all of our assets or any of our subsidiaries or other Hermes companies Healthcare is acquired by a third party, then your personal information that we hold will be one of the transferred assets.
 - d.. if we are under a duty to disclose or share your personal information in order to comply with any legal obligation, any lawful request from government or law enforcement officials and as necessary to meet national security or law enforcement requirements or to prevent illegal activity
 - e. in order to enforce or apply our terms of use, our customer terms and conditions or any other agreement or to respond to any claims, to protect our rights or the rights of third parties, to protect the safety of any person or to prevent any illegal activity or
 - f. to protect the rights, property or safety of Hermes Healthcare, of our staff, our customers or other individuals. This may include exchanging personal information with other organizations for the purpose of fraud protection and reduction of credit risk.
- 4.5 We may also disclose and use anonymous, aggregated reports and statistics about users of the AI Care & myAthlos platforms, applications, websites or our related services for the purposes of internal reporting or reporting to our team or third parties and for marketing and promotional purposes. **None of these anonymous, aggregated reports or statistics will allow our users to be personally identified**.
- 5. How long do we store your personal information?



We retain your personal information for no longer than is necessary for the purposes for which the personal information is processed. The length of time we retain your personal information depends on the purposes for which we collect and use it and/or as necessary to comply with applicable laws and to establish, exercise or defend our legal rights.

6. Your rights

- 6.1 You have specific rights in relation to your personal information. If you would like more information about these or would like to practice any of them, please contact us via email at privacy@hermes.health at any time. You have the following rights:
 - a. <u>Right of access.</u> You have the right to access any personal information we have about you. You can ask us for a copy of your personal information, confirmation of whether your personal information is being used by us, details of how and why are used and details of the safeguards that apply if we transfer your information outside the European Economic Area ("EEA").
 - b. <u>Right to update your information.</u> You have the right to request an update to any of your personal information that is outdated or incorrect.
 - c. <u>Right to delete your information.</u> You have the right to ask us to delete any personal information we hold about you in certain circumstances. You can ask us for more information about these specific cases by contacting us using the details in section 13. We will forward your request to other recipients of your personal information, unless this is impossible or involves a disproportionate effort. You can ask us who the recipients are, using the contact details on section 13.
 - d. Right to restrict the use of your information: You have the right to ask us to restrict the way we process your personal information in certain cases. You can ask us for more information about these specific cases by contacting us using the details in **section 13**. We will forward your request to other recipients of your personal data, unless this is impossible or involves a disproportionate effort. You can ask us which recipients use the contact information in **section 13**.
 - e. <u>Right to opt out of marketing</u>: You have the right to ask us to stop using your personal information for direct marketing purposes. If you exercise this right, we will stop using your personal information for this purpose.
 - f . <u>Right to data portability</u>: You have the right to ask us to provide your personal information to a third-party service provider. This right only applies when we use your personal information based on your consent or the performance of a contract. and where the use of your information is done by automated means.
 - g. <u>Right to object</u>. You have the right to ask us to consider any valid objections you have to our use of your personal information where we process your personal information based on our legitimate interest or that of another person or organization.
 - 6.2 We will consider all such requests and provide our response within a reasonable time (and in any case within one month of your request, unless we inform you that we are entitled to a longer period in accordance



with applicable law). Please note, however, that some personal information may be exempt from such requests in certain circumstances, for example if we need to continue to use the information to comply with our own legal obligations or to establish, exercise or defend legal claims.

6.3 If an exception applies, we will tell you when responding to your request. We may ask you to provide us with the necessary information to verify your identity before responding to any request you make.

7. Children

- 7.1 If you are under 18 years of age, explicit consent from your parent or guardian is required to purchase or use products or services of the AI Care & myAthlos applications and platforms.
